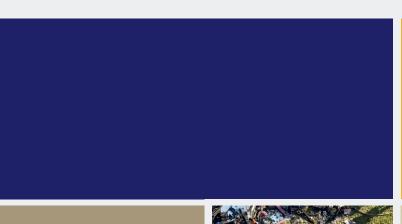

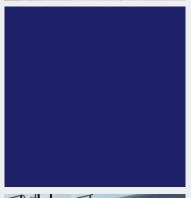

In 2024 we saw growth in many areas of our operation, to include increased training opportunities, increased services provided to the residents of Trumbull County, and the addition of a part time Emergency Management Specialist position.

Our focus in 2024 was reestablishing partnerships with our non-governmental organizations and starting the planning process for the rewrite of the Trumbull County Emergency Operations Plan.

We are proud to see growth within our recently established Special Operations Group, that consists of the Trumbull County Hazardous Materials Response Team, Trumbull County Fire Investigative Unit, Trumbull County Drone Response Team, Trumbull County Incident Management Assistance Team, Trumbull County Mass Causality Incident Response Team, The TCSO Dive/Water Rescue Team, and the Trumbull County Special Technical Rescue Team.

The Trumbull County EMA has continued to stay underbudget and continues to provide the services that our county has become accustomed to over the last three years. We look forward to 2025, and all the great things we have on the horizon.

2024 FINANCIAL REPORT



The Trumbull County Emergency Management Agency (TCEMA) started 2024 with a \$233,263.04 carry over from 2023 and ended 2024 with a carryover of \$252,269.49 moving into 2025. Our proposed operational budget for 2024 was \$248,450.00, and our actual expenditures were \$209,690.80.

The new per capita amount for Trumbull County Cities, Villages, and Townships moved from .21 per capita to .30 per capita in January 2024. This increase allowed the TCEMA to hire a part time Emergency Management Specialist, and expand the services provided to our customers.

We will continue to work diligently to work within the budget that has been set forth by the Trumbull County Executive Board, and do our very best to continue the growth of what the TCEMA can provide to the residents of Trumbull County.

SEVERE WEATHER EVENTS

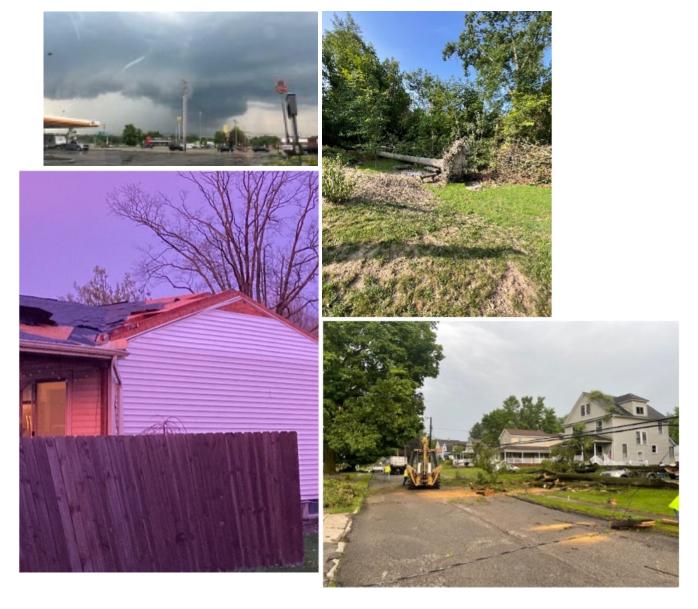


2024 was another active year for severe weather here in Trumbull County.

Here is the breakdown of events per the National Weather Service/Cleveland:

- Tornado Watches issued for Trumbull County = 2
- Tornado Warnings issued for Trumbull County = 2
- Severe Thunderstorm Watches Issued for Trumbull County = 6
- Severe Thunderstorm Warnings= 24
- Flood Watches Issued for Trumbull County = 2
- Flood Warnings Issued for Trumbull County = 0
- Flood Advisories Issued for Trumbull County = 6

Trumbull County experienced two EF-0 tornados in 2024, March 14th & April 17th. We also experienced severe wind storms in January and August, that were not determined to be tornados.



TRAINING

The Trumbull County EMA takes great pride in the ability to provide various trainings to a wide broad of disciplines serving not only Trumbull County, but many of our surrounding counties.

We are able to offer Incident Command System training, Hazardous Materials training, SkyWarn sever weather spotter training, and Public Information Officer training all free of charge to our students.

The purpose of the group is to bring all specialty groups underneath the umbrella of the Trumbull County Emergency Management Agency. 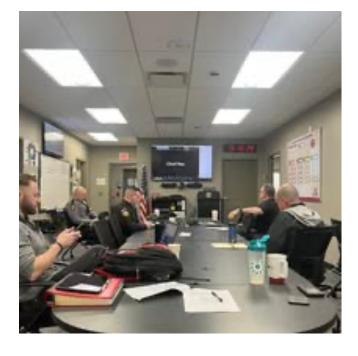




2024 ACCOMPLISHMENTS
